

## WAPELLO COUNTY BOARD PROCEEDINGS

Supervisor Siegel moved, seconded by Vice Chair Parker to approve the agenda. Motion carried.

Vice Chair Parker moved, seconded by Supervisor Siegel to approve the minutes of the September 3, 2013 Board meeting. Motion carried.

CANVASS OF THE SCHOOL ELECTION HELD SEPTEMBER 10, 2013. Kelly Spurgeon, Auditor, read the results of the canvass. The votes for the Ottumwa School District were as follows:

David Weilbrenner received twelve hundred fifty-five (1,255) votes

Michael Burton received nine hundred fourteen (914) votes

Carol Mitchell received seven hundred nineteen (719) votes

David Howard received six hundred sixty (660) votes

Torey Young received five hundred sixty-two (562) votes

Charles D. Coram received four hundred sixty-one (461) votes

The Board declared David Weilbrenner, Michael Burton and Carol Mitchell duly elected to the office of Director at Large for the term of 4 years.

Auditor Spurgeon read the abstract of votes for the Cardinal School District. The results were as follows:

Todd D. Hart received sixty-nine (69) votes

Mike Kayser received seventy-three (73) votes

The Board declared Todd D. Hart and Mike Kayser duly elected to the office of Director at Large for the term of 4 years.

Vice Chair Parker moved, seconded by Supervisor Siegel to approve Resolution #960-2013 to remove mobile homes from taxation and abate the taxes. Motion carried.

Supervisor Siegel moved, seconded by Vice Chair Parker to approve a request to hire Karen Blomme as a part-time Clerk at the American Gothic House, hire date 9/13/2013 at \$9.00/hr. Motion carried.

Vice Chair Parker moved, seconded by Supervisor Siegel to acknowledge Ruth Roth as a new part-time registered nurse at Wapello County Public Health, hire date 9/3/2013 at \$16.00/hr. Motion carried.

Supervisor Siegel moved, seconded by Vice Chair Parker to acknowledge a change of employment for Jackie Luna to full-time registered nurse at Wapello County Public Health, change date 9/30/2013 at \$18.69/hr. Motion carried.

Supervisor Siegel moved, seconded by Vice Chair Parker to acknowledge a change of employment for Ruth Roth to full-time registered nurse, change date 9/25/2013 at \$16.00/hr. Motion carried.

Supervisor Siegel moved, seconded by Vice Chair Parker to approve a contract with UMR, Inc. Motion carried.

Jennifer Vitko, CPC, discussed how county-funded clients receiving mental health funding through her office will be affected with the new changes. In a letter she's creating, she explained that her clients are to contact her office to help them enroll. Vice Chair Parker moved, seconded by Supervisor Siegel to approve the amended letter. Motion carried.

Vice Chair Parker moved, seconded by Supervisor Siegel to approve a tax suspension under Iowa Code 427.8. Motion carried.
