Chair Morgan opened the meeting. Vice Chair Huit moved, seconded by Supervisor Parker to approve the agenda. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Huit to approve the minutes from September 22, 2020 board meeting. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Huit to approve contract to paint Dahlonga School and handicap ramp to Carnes Painting & Staining in the amount of \$6800.00. Motion carried.

Vice Chair Huit moved, seconded by Supervisor Parker to appoint Peggy Thie to the Board of Adjustment. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Huit to approve Tax Suspension under Iowa Code Section 427.8. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Huit to forward bids to A&J Associates with recommendation to the board for Wapello County Courthouse Sprinkler System. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Huit to approve Resolution 53-2020 to set 10-6-2020 at 9:45 a.m. as date & time for a public hearing for road vacation – Reddick Road (67th Street). Motion carried.

Supervisor Parker moved, seconded by Vice Chair Huit to approve Resolution 54-2020 to set 10-6-2020 at 9:45 a.m. as date & time for a public hearing for road vacation – Priest Road. Motion carried.

Deputy Chris Shadduck & Joel Pedersen, Cardinal School requested support from the Board using general funds for a turning lane on State Hwy 16. Supervisor Parker stated he was not against helping fund the project but wanted the county to be the last contributor. The project is estimated at \$320,000.00. Supervisor Huit felt since it was a state highway that the State - DOT should fund this project. Pedersen said he would get back with the board at a later date.

Supervisor Parker moved, seconded by Vice Chair Huit to approve Resolution 58-2020 road closure for Project BROS-SWAP-CO90(80)—SE-90, Bridge 194 on 225th Avenue over North Avery Creek. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Huit to approve BNSF Construction Agreement for Project BROS-SWAP-CO90(80) – SE-90, Bridge 194 on 225th Avenue over North Avery Creek. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Huit to approve contract with IDPH for staffing of a Test Iowa Clinic. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Huit to approve Resolution 59-2020 abating certain property taxes for Willard Street Methodist Church. Motion carried.

Supervisor Huit moved, seconded by Supervisor Parker to approve request for payroll approval – new hire for Sara Glosser, Part-Time Clerk in the Recorder’s Office. Motion carried.
